# Lancaster County Art Association National Juried Exhibition June 13–July 22, 2010

## Eligible Works

All original work in all media is eligible for entry. Work previously shown in the LCAA galleries will not be accepted. Artwork must have been completed in the past three years. The exhibit is open to all artists 18 years or older.

## Categories

Oil & Acrylic, Watercolor, Photography, Sculpture & Ceramics, Other Media (pastel, mixed media, etc.)

## Awards

\$3,000 in cash prizes will be awarded by the juror.

- Best of Show - All Media - \$500
- First Place in each Category - \$250
- Second Place in each Category - \$150
- Third Place in each Category - \$100

## Exhibition Dates

The exhibit will open with a reception on Sunday, June 13, 2010, from 1 to 5 PM. Awards will be presented at that time. The exhibit will continue through July 22, 2010.

## Sales

All sales will be processed through the LCAA. The LCAA will retain a commission of 30%. Artwork not for sale should be marked "NFS". We will not accept work marked "Price on Request."

## Display of Work

All artwork must be framed and securely wired for hanging (saw tooth hangers are not acceptable.) All 2-D works must be matted and framed under glass or plexiglass except oils and acrylics treated like oils. Work on canvas with finished edges is acceptable. No frames that leave the edges of the glass exposed will be accepted. Entries should not exceed 45" in any direction (including the frame). Sculpture should be mounted on a suitable base. The LCAA reserves the right to reject any entry that is not suitable for display.

## Delivery & Return of Work

All accepted work must be hand-delivered to the LCAA at 149 Precision Avenue, Strasburg, PA on the following dates: June 4, 5, and 6 from 1 to 5 PM on each day. Artists who live more than 150 miles from the LCAA may ship their work which should arrive from May 26 to 28. Pieces that weigh over 100 lbs must be hand delivered on June 4, 5 and 6 from 1 to 5 PM. All artwork must remain in the LCAA gallery until the close of the exhibit. Dates for pickup of artwork are July 23, 24, and 25 from 1 to 5 on each day.

## Liability

The LCAA will insure artwork accepted into the exhibition for two-thirds the listed sale price with a net maximum of \$1,000 per item. The LCAA will not be responsible for minor nicks to frames, breakage of glass or scratches to plexiglass.

## Rules for Entry

Artists must submit the following items to the Lancaster County Art Association, 149 Precision Ave., Strasburg, PA 17579.

## Slides or Digital Images:

All submissions are by 35 mm slide or as digital images on a CD and are subject to jury action. Slide must carry the name of the artist, the medium, the category, title, dimensions (including frame), and indicate the top of the slide. 1-3 slides or JPEG images per artist. CD must be labelled with the name of the artist, the titles of the artworks, and the category in which the artworks are entered.

• **Digital Images:** If submitting digital images, provide unenhanced unmanipulated jpeg (jpg) images oriented properly on a CD or DVD. When saving your jpgs, save at the high quality standard setting and for use on ANY computer including Apple computers. Files will be uploaded to an Apple computer.

• The longest dimension of your digital image should be no longer than 2,100 pixels and the final file size of the saved jpg should not exceed 5 Mb. **Do NOT send files that are embedded in any applications that must be run to view the jpgs. Send no files that end in exe!**

• CDs will not be returned. Images must depict the artwork accurately. Package CDs with adequate padding. CDs are brittle and can break.

• Use as file names the artist's initials followed by the image number as given on the Entry Form and one word from the image title. For example, the file name of Jane Doe's image, Little Bear, #1 on her Entry Form would be jd1bear.jpg. One to three entries may be submitted on a CD with one image of each entry. Sculpture entries may have one additional view of an entry if necessary at no extra charge.

• **Entry fee:** \$10 per artwork submitted by LCAA members. \$15 per artwork submitted by non-members.

• Checks should be made out to the Lancaster County Art Association. All entries are non-refundable. Non-members may become members and take advantage of the lower rate for entry fees. Please include a separate check for membership.

**Memberships: - Adult \$40, Senior \$30.**

## Check List:

✓ **Entry form:** Complete the entry form, making sure the labelling of slides or jpg images corresponds with the form.

✓ **Jury Notification Form:** Complete the notification form, making sure slides or digital images correspond with the form.

✓ **SASE:** Enclose a self-addressed stamped #1 envelope for notification of acceptance and return of slides. Postage must be adequate to cover return of slides.

***All entries must be postmarked no later than April 3, 2010.***
