

LCAA Members are Invited to Exhibit at the Art Vault: Celebrating 90 Years of Creativity!

A unique, exciting, exhibit opportunity exclusively for members of
Lancaster County Art Association

LCAA has arranged with the Art Vault (100 North Queen Street, Lancaster, PA) to host a members' show from July 3, 2026, through August 2, 2026. (LCAA Artists may also offer prints for sale at The Art Vault during the exhibition dates.)

The show opening date is First Friday for the July 4th Weekend (July 3, 2026).

The LCAA 90th Year and Awards Reception will be on Thursday, July 9, 2026, 6-8 p.m.

How to Exhibit: (Please check the LCAA/VAULT Criteria Page for more details)

Images for up to three (3) pieces can be submitted for consideration. 2d and/or 3d. There is no official theme. There is no date of completion requirement. As per the agreement with The Art Vault, all pieces must be for sale at a price reflective of previous price for the work. One, two or three of your submissions will be accepted depending on exhibit space. Artists will be responsible for delivering artwork directly to The Art Vault.

There are two ways to submit for consideration: Electronically or In Person

Your art images will be posted on the Art Vault website in advance of the exhibition.

Electronically: By May 17, 2026 Deadline

Submit .jpeg or .bmp images of up to three (3) of your favored works with a submission fee of \$45.00 (For 1,2, or 3 submissions.)

Email (attach) your three images to: LCAAexpo@gmail.com. Label each image file by your last name, title, and size. E.g. "Smith-Forest Grove-18x24" must appear under the image icon. By May 17, 2026.

Payment can be made by mailing or hand delivering a check to LCAA; or calling the credit card to LCAA (717-687-7061, Thurs.-Sat. 11-4, Sun, 1-4) There is a 4% surcharge (\$1.80) on credit card payments.

In the same email as your image submission, include your name for listing, your phone number, and your address.

In Person: (And all Artists 16 years and younger) (At LCAA, 1-4 p.m., May 14, 15, or 16)

For those needing photography or needing help with submitting, you can bring up to three pieces to the Art Association (149 Precision Av., Strasburg. PA) 1-4pm on Thursday, May 14, Friday, May 15, or Saturday, May 16, 2026 for review. If there are questions about framing, matting, etc., members of LCAA will assist at that time.

Submission payment can be made at that time: \$45.00 cash or check. (add 4% for credit cards)
Young Artist (under 16): \$15.00.

Artists will be notified by May 25,2026

Artwork to be delivered to the Art Vault before or by June 20, 2026]

LCAA/VAULT Criteria Page

There is no theme for this exhibit.

There is no completion date requirement

There is no size limit, but works over 36" in width might be rejected due to space.

Information on Selected Works:

- As per the agreement with the Art Vault, all information (artwork to exhibit and sizes) will be organized by LCAA and submitted by June 5, 2026.
- Images of the works will be posted on the Art Vault website

Proper Artwork and Hanging Structure:

- Each piece must be suitably prepared for exhibition, hanging, and labeled with identification. Frames must be secure and properly wired: with wire approximately 1/3 below the top of the frame.
- 3d Pieces, must be stable and secure, ready to place on pedestals.
- If there are any questions, please visit the LCAA on the dates for the in person submissions.
- The Art Vault may reject any piece that they feel is inadequately prepared for exhibition (structure, wiring, etc.) The Art Vault will be hanging and labeling the show. Their hanging plot will be generated by the image information submitted.

Delivery:

- Delivery: The pieces that have determined by LCAA are to be delivered by each artist directly to the Art Vault (100 N. Queen St. Lancaster) on or before June 20, 2026. (Via the front door on Queen and Orange Streets)
- Large pieces may be driven from the access at Binn's Park to the front door. Vehicle flashers must be active.

Retrieval of Artwork:

- All artwork is to be retrieved by each artist and removed from the Art Vault after the show closes beginning on August 3, 2026.

Offering your Prints for Sale

- Any LCAA member who enters is also qualified to sell prints of their work during the weeks of the exhibition.
- Prints must be labeled and "wrapped" for sale in the Vault print rack.

Deadlines Summary:

May 17, 2026: Electronically submit images for up to three(3) works for consideration and fee paid/ Or:

May 14/15/16, 2026: Bring up to three(3) works for consideration, photography, and guidance, and all young artists under 16

May 25, 2026: Artists notified which works are considered

June 5, 2026: LCAA submits selected images, sizes, artist information to Art Vault to draw the exhibition/hanging plot, create labels and promotion on Vault website.

June 20, 2026: Deadline for artists to deliver works (and prints) directly to the Art Vault

July 3, 2026: Vault Opening Reception, First Friday

July 9, 2026: LCAA Reception and Award, 6-8 p.m.

August 3, 2026: Artists retrieve artwork (and prints)
